Consolidated Reports on the implementastion of RTI Act MUST BE FORWARDED BY THE CONCERNED ADMINISTRATIVE HEAD OF DEPARTMENT.
2. Annual consolidated report on the implementation of RTI u/s 25(3) of the RTI Act,2005 shall cover the period from 1 April to 31 March of each year corresponding to the financial year period.
3. Public Authorities/Departments which have **not received any RTI applications** during the period are still required to furnish even a NIL report
4. Henceforth, all Departments/Public Authorities shall furnish the report on the implementation of RTI for the coming years as per this format till further notification.
